ARTICLE 3

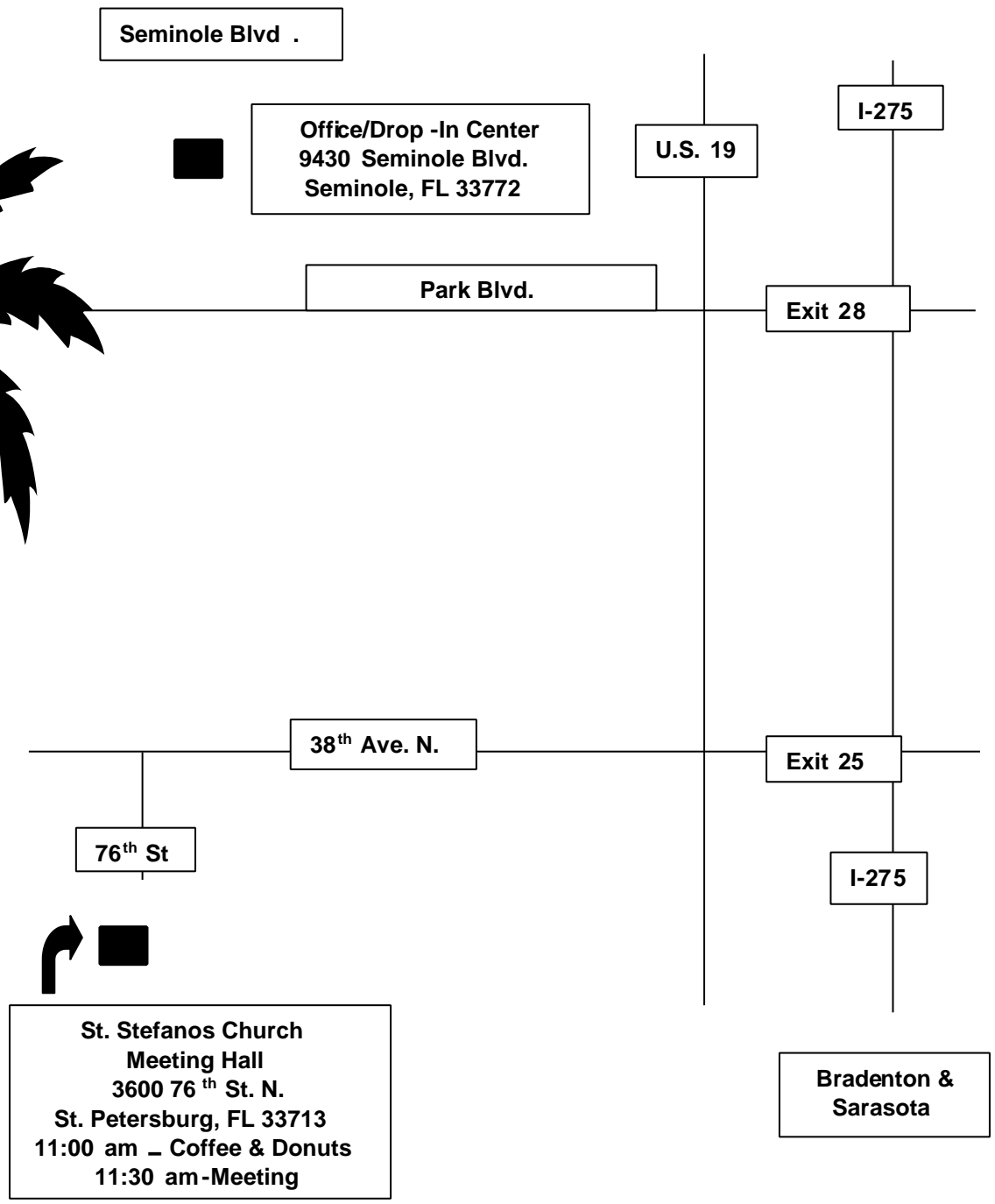
MEMBERSHIP

- A. **(New Language) Membership in the Retired Workers Chapter, Area Council, or International Area Council, is available to all retired members within the geographical area of the Local Union, Area Council, or International Area Council, provided they are eligible under Article 6, Section 19, and Article 55, Section 5(a) of the Constitution of the International Union, and who registers with the Local Retiree Chapter, Area Council, or Retiree International Area Council. (As stated in the UAW Retired Workers Letter, dated April 15, 2019)**
- B. **(New Language) Associate Status for spouses and surviving spouse of eligible UAW retirees, shall be pursuant to the requirements contained in Article 55, Section 7 and the Administrative Procedures. (As stated in the UAW Retired Workers letter, dated April 15, 2019)**
