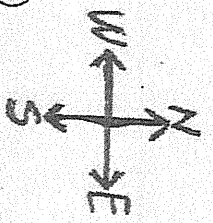
We are here to help in any way we can. If you just want to stop by the drop in center to discuss anything when you are in the area, please do so.

Hope to see you all at our upcoming meetings.

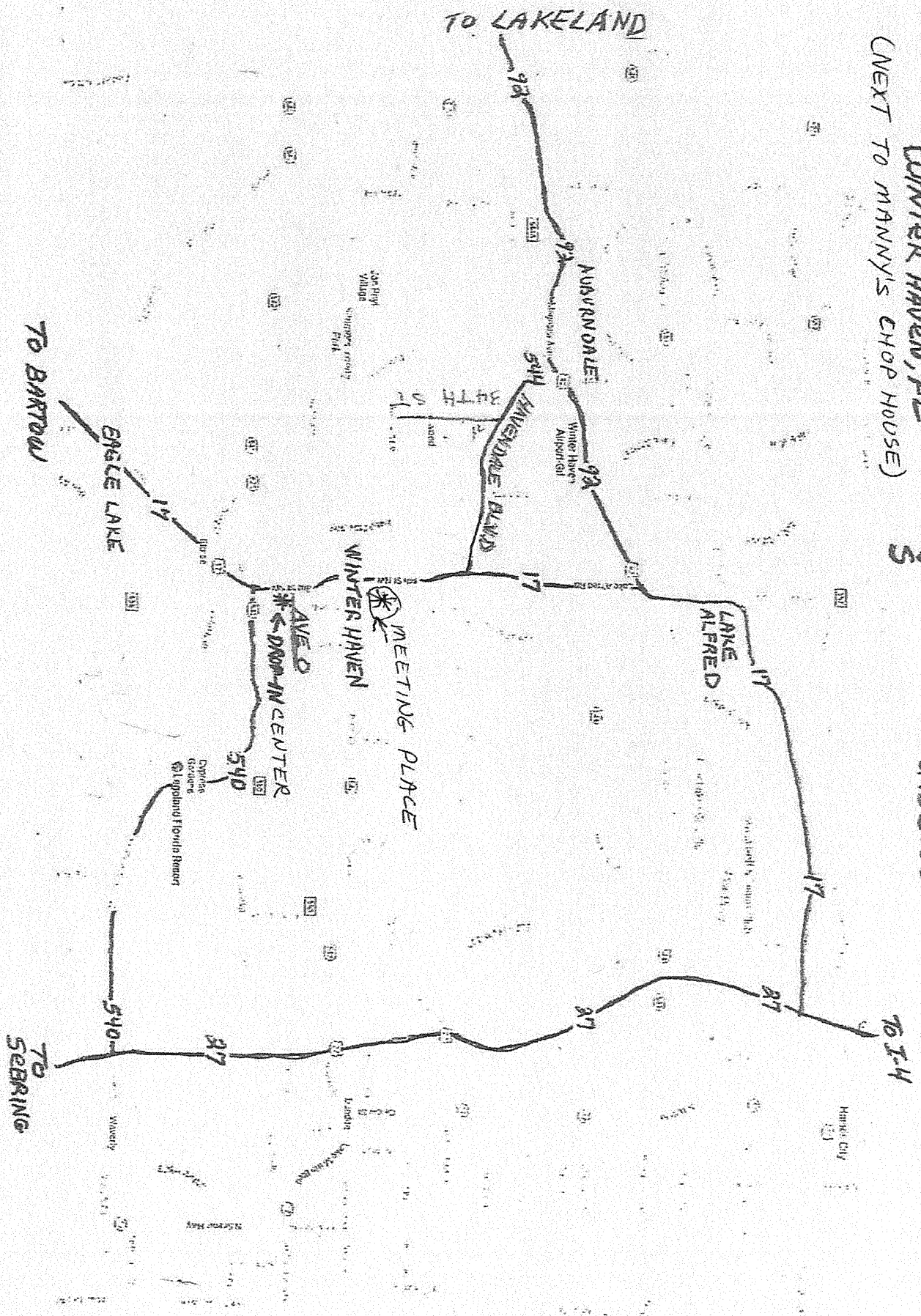
